Outdoor booths are located on the cement drive or grass field at the discretion of the management, with no provided structure, and do not include electricity. Outdoor booths receive a \$50 discount on the regular booth price.

I/we grant permission to the Crozet Arts & Crafts to reprint an image for promotional use of the Crozet Arts & Crafts Festival. This includes the use in press releases, print, online, television, and the Festival web site. I/we certify that I/we am/are the artist/s who creates the work I/we sell and not an artist representative or wholesaler. I/we understand all booths will be visited by the Festival committee at intervals throughout the Festival to ensure that all exhibitors comply with all Festival rules. I/we further agree to abide by all regulations outlined in this application, the load-in and load-out instructions, security procedures, or any rule promulgated by the Festival Director. I/we acknowledge that failure to abide by regulations and repeated non-compliance will result in expulsion and ineligibility for judging, awards, and participation in future Crozet Arts & Crafts Festivals. Expulsion of a participant from the Crozet Arts & Crafts Festival is without the necessity of any written notice and without legal recourse or right to rebate any portion of the fees paid.

Each artist must insure his/her property against the risks of fire, theft, burglary, breakage and leakage, and weather or water damage as well as the risks of transport to and from the festival site. The Crozet Arts & Crafts Festival will not be liable to any artist or any other person for any damage or loss whatsoever, arising from any cause.
